November 21, 1988

Meeting called to order by Chairman Chace pursuant to law. Flag salute. Chairman notes the agenda was posted November 17, 1988.

PRESENT: Supervisors Schreiber, Anderson, Jones, Coulson and Chace.

Minutes of the November 7, 1988 meeting approved as filed.

HOSPITAL REPORT:

Mr. Kent Aland, Hospital Administrator, requests authorization to purchase laboratory and radiology department equipment for the Modoc Medical Center, in the approximate amount of \$45,000.00 with a 60% payback from the state.

ORDERED on motion of Supervisor Jones, seconded by Supervisor Anderson, that the equipment purchase as outlined by Hospital Administrator in the approximate amount of \$45,000.00 with a 60/40 split with the state reimbursing the county 60%, be approved.

Mr. Alandrequests the Board declare a 1972 GMC Van and a 1973 GMC pickup surplus property and that the proceeds from the two vehicles be applied to the balance due on the 1977 Chevrolet pickup.

DEPARTMENT OF MENTAL HEALTH:

Robert C. Gillaspie, Director of Mental Health/Alcohol & Drug Services pursuant to request of Board of Supervisors reports on the Utilization of the Modoc Medical Center as a Psychiatric Skilled Nursing Facility and for Alcohol and Drug Recovery Placement facility. Mr. Gillaspie reports that to utilize the Modoc Medical Center for Alcohol and Drug Recovery Placement would require State Licensing and Certification. New Residential start-up costs are very expensive and there are no state funds available therefore it would be dependent on insurance and patient fees. He advises the Board that most counties are losing money and the program success is not cost effective. Utilization of the Modoc Medical Center as a Psychiatric Skilled Nursing Facility would require two (2) certifications: one from the Dept. of Health Services and one from the Dept. of Mental Health. Funding requires a State Department of Mental Health contract for payment, and at this time no new contracts are available due to funding shortages. Probability for program implementation is Mr. Gillaspie advises Board members that an poor at this time. option would be to solicit bids from a private provider, i.e. Crestwood Inc., for program provision. Chairman Chace thanks Mr. Gillaspie for his report.

DEPT. OF PUBLIC WORKS/ROAD DEPT:

ORDERED on motion of Supervisor Coulson, seconded by Supervisor Jones, that Resolution No. 88-53 be adopted, approving the appliation for grant funds for the per capital grant program under the California Wildlife, Coastal, and Park Land Conservation Act of 1988 for the Modoc County Courthouse repair project. All Ayes.

A letter is read from Dave Davison, representing California Pines Property Owners' Association requesting 25 MPH speed signs on Grande Road in the California Pines development. It is further requested that speed limit signs be placed on Pumice and Spring Roads in Castle Rock Estates.

Proposed ordinance is read amending Ordinance 219 to add the following speed zones as requested by California Pines Property Owners' Association. Second reading of ordinance scheduled for December 5, 1988 Board meeting.

ORDERED on motion of Supervisor Jones, seconded by Supervisor Anderson, that Resolution No. 88-54 be adopted, to notify the Caltrans District Director of Transportion that the County of Modoc claims the Federal Aid Secondary Funds in the amount of \$272,277 and State Highway Matching Fund Money in the amount of \$100,000, and hereby agree to provide any County matching funds required as may be necessary.

COMMUNITY FACILITIES DISTRICT NUMBER ONE (MODOC COUNTY LIBRARY SYSTEM)

A motion is made by Supervisor Anderson, seconded by Supervisor Jones, that Resolution No. 88-56 be adopted, that finds and determines that the requisite two-thirds of votes cast in an election pursuant to Section 53326 of the Mello-Roos Community Facilities Act of 1982, Chapter 2.5 of Part 1 of Division 2 of Title 5 of the California Government Code, as amended, are in favor of levying the special tax of \$18.00 per landowner per year for the purpose of providing a full-service library system serving all of the residents of Modoc County. The Office of Modoc County Assessor is hereby designated as the office to be responsible for annually preparing the current roll of special tax levy obligations by assessor's parcel number on non-exempt property within the district, to be responsible for estimating future special tax levies, and to respond to inquiries concerning current and future tax liability.

Librarian Chism requests \$37,000.00 to \$40,000.00 to keep the library open during the six (6) months. The matter to be placed on the agenda for December 5, 1988.
